

EXCLUSIVE: Pico Rivera Councilman David Armenta Used Influence to Initiate Arrest, Family Alleges

FAMILY MEMBER FACES FOUR LIFE SENTENCES; ALLEGED VICTIM HAS BEEN ARRESTED MORE THAN 100 TIMES AND IS IN AN ARIZONA JAIL SERVING A 7-25 YEAR SENTENCE.

Ramily, friends and community members are questioning if a jailed Pico Rivera man deserves to be facing four life sentences for a crime they contend he did not commit, alleging that David Armenta, an elected member of the Pico Rivera City Council, was heavily involved in a behind the scenes influence scheme to "manipulate" deputies and "distort facts" to have him arrested by the Pico Rivera Sheriff's Department.

George Karavolos, age 38, has been locked away in the LA County Men's Central Jail since May 23, 2012, with a \$4 million bail hanging over his head.

The 5.1 earthquake that struck last Friday night did cause some damages to both residential and commercial structures in and around La Mirada, Norwalk, Whittier and La Habra.

The epicenter of the 5.1 earthquake, which occurred at 9:09 p.m. at a depth of 4.6 miles, was located 3 miles southwest of Rowland Heights and 4 miles north of Fullerton, according to the U.S. Geological Survey.

"It was felt pretty much throughout the populated part of Southern California," said Caltech seismologist Kate Hutton. The earthquake expert said the number of incidents was "actually pretty expected for a magnitude 5.1 earthquake," Hutton told members of the media.

Even though most of the damages were considered to be "minor to moderate," several people told Hews Media Group-Community Newspaper that they sustained "lots" of broken dishes, glass picture frames, cracks in walls, and even busted water pipes.

In La Mirada, Whittier and La Habra at least a half a dozen water main pipes cracked in both residential and commercial area streets causing several ntersections to be closed temporarily into early Sunday morning due to flooding. In Downey, Fire Station 62 reported that one light pole was down, but a specific location was not disclosed.

In Cerritos, hundreds of concert goers at the Cerritos Center for the Performing Arts felt the earthquake at the start of the intermission from jazz performer Chris Botti. Several were stuck temporarily in elevators, and many of those in attendance screamed "earthquake" before exiting out of the location.

Several hundred bottles of wine and other spirits crashed to the ground and broke at the Albertson's Supermarket at 15200 East Rosecrans Avenue. "It was like a sea of red wine exploded," an employee of the store told HMG-CN in a phone call on Monday. No one was injured at the store.

La Mirada City Manager Jeff Boynton said that no major damage was reported to city owned facilities.

Boynton did say there was a "unconfirmed report" that a water line broke in the Greenhills neighborhood of La Mirada, but he was still getting a "positive confirmation" from a local water utility about the extent of the situation.

"We were spared here in La Mirada, as compared to our friends in La Habra and Whittier who had much more structural damage reported," Boynton said.

Interview with Tony Mendoza, 32nd Senate District Candidate

Tony Mendoza was born and educated in South Central LA, the second youngest of nine children. Mendoza was raised in a single parent home; knowing the struggles of migrant working families and the opportunities that a good education provides. He was the first in his family to attend and graduate from college. He enrolled at California State University, Long Beach where he earned his Bachelor's Degree in Political Science.

Mendoza has been in office for 16 years, supporting many issues and standing for what he believes to be in the best interest of his constituents. His personal philosophy being "I am a public servant leader and I am here to help".

Hews Media Group [HMG]: Tell me who Tony Mendoza is?

Tony Mendoza [TM]: I have been in politics for quite some time. I was 25 years old when I ran for a Council seat in Artesia. That year was hectic. I was teaching elementary school in East LA., a first year Councilman and I also met my wife that year. It was an incredible year.

HMG: Do you still teach?

TM: I am substituting. It allows me the freedom to pursue my candidacy, while allowing me to get back into the classroom and see what is really going on. Particularly in Los Angeles, it is such a large district.

HMG: What transitioned you from being a teacher into politics?

TM: I actually wanted to be a public administrator, but when I was still in college, the city council got me kind of upset. They were not taking care of the needs of the northern part of Artesia. At the time it was predominately Latino and there were

gangs, drugs and prostitution in the community and I felt the council was completely neglecting that area. When I approached the council about these issues, and they completely disregarded me. Their response was racist and bigoted. I realized that many of their terms of office would be up soon, so I ran for City Council. I went



door to door introducing myself in a grassroots campaign and got elected.

HMG: Tell me why constituents' should vote for you?

TM: if you look at my track record, I feel I have served the citizens well. I consider myself a 'servant leader'. Many issues came up in the Assembly, which I stood against. I vote for what is right for the district. In 1997, I became the youngest and first Latino member of the Artesia City Council and to serve as the city's mayor. After three terms with the city council and teaching for 10 years, I decided I could better serve the citizens and the community by running for State Assembly.

HMG: What issues did you vote against, that set you in detriment with your peers in the Assembly?

TM: One that I feel was most important was redevelopment. This would allow cities to have an economic development tool to bring in businesses and create jobs. The State voted to eliminate redevelopment; all of our cities were up in arms. I was one of the few Senate members that voted to keep redevelopment. The Senate and the Speaker were adamant about removing redevelopment. I did not support their cause, which created much stress in my office. After my vote, mysteriously any and / all my bills were not passed. I stood in opposition of the disincorporation of Vernon; I was the only Democrat that voted against this.

HMG: How do you see yourself transforming the life of Californians?

TM: I have done my homework and paid my dues. I know the issues. I know the pros and cons of the Water Bond issues, the environmental concerns, job concerns and educational problems. My bill AB 97 made California the first state in the nation to ban the use of Trans Fats-the healthdeteriorating food ingredient, this has now become the standard all across the nation. The parenting education legislation, AB 1291, passed in 2007 allows judges to sentence the parents of children with first-time gang offenses to anti-gang parenting education classes that prevent further involvement in gangs. And I also passed AB 22 which prohibits the use of Credit Checks in the hiring process. I believe my track record speaks for itself. I consider serving the public my calling, politics is just what we do, but to serve the public and keeping that my focus is the key.

Norwalk, Downey Leaders **Break Ground on Firestone Bridge Replacement Project**

City officials from both Downey and Norwalk gathered on Thursday afternoon to signal the beginning of construction on the new Firestone Boulevard Bridge Replacement Project.

The Firestone Boulevard Bridge Replacement Project will involve the replacement of the existing Firestone Boulevard Bridge at the San Gabriel River in its entirety with a new bridge to meet current standards with wider sidewalks, center median and shoulders. The same number of travel lanes (six) will be provided on the new bridge. The City of Norwalk is the lead agency on the project.

On March 4, 2014, the City of Norwalk City Council awarded a contract to Reyes Construction of Pomona in the amount of \$7,586,493 for the construction of the bridge.

Based on the bid received from Reyes Construction, the total estimated cost of the project, including construction engineering, contract administration and contingency, is approximately \$9.5 million.

The project will be funded through a federal grant, which will fund 88.53% of the project cost and a Proposition C discretionary grant through the Los Angeles County Metropolitan Transportation

Authority (Metro), which will fund the remaining 11.47% of the project cost.

Construction is scheduled to commence in April 2014 and be completed by December 2015. The project will be constructed in five separate stages.

Valley View Grade Separation Continues Progress



The Valley View Grade Separation Project continues to make steady progress and is on track to be completed by early September.

With the railroad tracks successfully installed on the new bridge structure crossing over Valley View Avenue, crews have been busy completing excavation work to create the underpass. More than 103,000 cubic yards of dirt have been excavated from the site. The excavated dirt was transported and used as fill material on a separate construction project at the Port of Los Angeles.

Construction of the roadway is set to begin later this month and will occur in two phases. The first phase will see construction of the northbound lanes. Once that is complete, phase two construction of the southbound lanes will begin. During this time, all traffic will be moved onto the newly built northbound lanes, with two lanes in each direction, and the current detour will be closed for removal.

Los Alisos Teachers Tapped to 'Lead the Way'

NORWALK - Two teachers at Los Alisos Middle School are among an elite few in the country who were chosen to be "Master Teachers" with Project Lead the Way (PLTW), the nation's leading provider of Science, Technology, Engineering and Mathematics (STEM) programs.

Angelica Gunderson and Kelly Garcia will spend a few weeks this summer training teachers from around the country PLTW's Gateway to Technology Medical Detectives curriculum, in which students analyze genetic testing results to diagnose disease and study DNA evidence found at a make-believe crime scene. "To be part of something like this is amazing," Gunderson said.

The program has been recognized by colleges and universities, Fortune 500 business and several other organizations. PTLW programs are utilized in 5,000 schools across the country, including those at Norwalk-La Mirada Unified. The curriculum is also aligned with the Common

CRIME SUMMARIES Mar. 17-23

CERRITOS

The following information is provided by Hews Media Group-Community Newspapers as a community service.

Reported Part I felony crimes continue to see-saw week-to-week (19, then 11, and now 18 this past week). The following is a breakdown of crimes by category: no robberies (very good news); two residential burglaries; one commercial/other burglary; four grand thefts; seven vehicle burglaries; and four stolen vehicles. Deputies made five felony arrests, 14 misdemeanor arrests, three warrant arrests, and issued 142 traffic citations. The Sheriff's dispatch center also received 324 calls for service, a considerable increase from the 273 received the previous week.

At about 10 a.m. on Wednesday morning someone attempted to enter a home in the 11200 block of Rose Avenue by prying a side door. This was an attempt only as no entry into the residence was made. The other residential burglary occurred in the 17400 block of Jeffrey Avenue sometime Friday morning through early Saturday afternoon. The front door of the residence was kicked in, but the loss is undetermined at this time. The good news is that fingerprints were obtained in this case and a suspect has been identified. When investigators canvassed the neighborhood to seek out witnesses, a nearby neighbor commented that a woman had knocked on his door during the time period that the burglary took place. He was unable to understand what she was saying so he closed the door. The description provided by the neighbor matches the suspect whose fingerprints were found inside the burglarized residence (an arrest, as they say, is imminent). This case is a good example of how important it is for homeowners to be on guard for "knock-knock" burglars. Two crime prevention phrases come to mind when reviewing these cases: "Lock it, Hide it, Keep It," and "If You See Something, Say Something."

The commercial/other burglary involved the loss of a handheld radio at Mary Bragg Elementary School. Either late Wednesday or early Thursday morning someone pried a classroom window and stole the radio. Four other bungalow windows also had pry marks, but no entry was made.

Late Sunday or early Monday morning someone took \$1 from a Lexus parked in the 17856 block of Hoffman Avenue. On Tuesday evening a driver's window was shattered on a Honda Pilot in the 18100 block of Dumont Avenue and a wallet and cash were stolen. On

It, Hide It, Keep It." The grand thefts involved the loss of \$7,000 worth of copper wire at a business in the 14133 block of Arbor Place. A tailgate on a Ford F-250 was stolen in the 13100 block of Briarwood Street. A suitcase containing electronic items was stolen from a bus stop on the corner of South Street and Bloomfield Avenue. Two suspects stole the side saddles, a jacket, and the cover from a motorcycle parked in the 15900 block of Puima Avenue. And an employee was arrested for stealing about \$7,500 in jewelry from a kiosk in the Macy's store in the mall.

Finally, three vehicles were reported stolen this past week, two in residential areas and one at the Towne Center. A Kia Sorrento was stolen on Thursday from the 13000 block of La Jara Street. This vehicle was recovered the same day in Norwalk. Also on Thursday an older model Honda Accord was stolen at the Towne Center. And sometime late Friday through Sunday morning a GMC pickup was stolen from the 13400 block of Village Drive.

High Water Table Beneath La Palma Dredges Up Concerns, Benefits

This is a look at the water table that sits under the city limits in La Palma. Joo interviewed several sources inside La Palma City Hall for research purposes.

La Palma residents have always been focused on the high water table that literally sits just below ground.

It is no secret that officials at La Palma City Hall have always had to handle problems and concerns from residents and business owners about having a one of the highest underground water tables of any city in the western Orange County area.

The residents of La Palma literally sit right on top of water, but unlike most cities, La Palma's water table is more elevated. The La Palma water table is on the border between the water-saturated ground and the unsaturated ground and officials worry that too high of a water table can interfere with many parts of citizens' daily lives, including the possible impact on future developments of public projects.

Cities, similar to La Palma, have a of the world. harder time creating and having public works approved than other cities that have a normal water table.

The liquid from the "water table" can come from either a form of precipitation or irrigation from agriculture. Since, the levels of the water table are determined by nature, water tables in a given area tend to fluctuate.

The water beneath the ground in La Palma is used as community's drinking water. Specifically, the City of La Palma's drinking water is located around fifty to sixty feet below the ground while the water from precipitation and irrigation is only about ten feet below the ground.

From the ground, water sinks through the ground and is filtered through the soil and rocks. This process of filtration is called saturation. Saturation makes it safe for humans to drink water from the water below us.

Aquifers are saturated rocks underground that are filled with water; they are used to take out water from the ground in an easy and efficient manner. "Aquifer depletion" occurs when aquifers are used more than they are replaced by more water. Although, this isn't a current problem for La Palma, it is a problem in many parts

The shape of the water table is affected by the region's topography, geology, and weather. Because the rocks absorb the water, geology determines how much water rocks can hold influences the levels of the water table. The water table will usually be a lot higher during the rainy and wet seasons, but lower when the weather is hot.

The Community Development Department in the City of La Palma has to work above and beyond to complete tasks to counter the high water table.

First, the department would, of course, have to have a reason to build. Once it has the motivation to do so, the Community Development Department would find a site to build a project or to fix something in need of repair.

Then a geotechnical study is conducted to assess the conditions that might lead to future despair.

A geotechnical study determines the soil conditions and water content for the geologist to give the department advice on how to stabilize the conditions to make construction possible.

For example, the geologist can advise the department to dig out the possibly dangerous native soil and replace it with



The environmental impact study figures out the possible social, environmental, and economic consequences that the project could create. Once all the studies are conducted, the actual design plans are then produced for construction.

The high water table in La Palma creates an abundance of problems.

The high water table requires the Community Development Department to initiate more studies and to solve more problems to stabilize the site.

For instance, if a pipe underground breaks and needs to be repaired, a trench must be dug to reach the site. If the water table is higher than where the damaged pipe is, the water must be contained or pumped out of the trench so the workers can reach the pipe to fix it in a safe manner.

The high water table in La Palma can also lengthen construction jobs because there are additional steps required to complete a project. This causes more money to be spent for development projects due to the longer schedule. There is also a larger safety issue due to the overwhelming amount of water.

Cities dealing with a high water table undergo many more obstacles than other normal cities.

The Community Development Department in the City of La Palma must jump over more hurdles to complete a project.

Unlike other regions, La Palma must conduct more studies, like geotechnical and environmental studies, on the site of the future job.

They must then commit more manpower to make sure it's completely safe to build or to repair a project, which costs more money.

Having a high water table in a city can raise more issues and concerns than in a city with a normal water table.

For the people of La Palma, what goes on under their feet sometimes goes unnoticed, and city officials wouldn't have it any other way.

He was arrested in a bizarre alleged kidnapping scheme that law enforcement officials are saying was carried out by members of a Pico Rivera street gang.

On May 18, 2012, career criminal Jones was caught in the act of committing a burglary in the city of Montebello. Following his arrest, Jones alleges that someone named "Doug" from Pico Rivera "kidnapped him", "tortured him" and "forced him" to commit the crime against his will.

The case was transferred to the Pico Rivera Sheriff's and soon thereafter Karavalos was arrested and booked in Pico Rivera.

Karavalos is being accused of Extortion, Aggravated Mayhem, Torture, Kidnapping for Ransom, Gang Enhancement, and Criminal Threats against the alleged victim Andrew Jones.

Hews Media Group-Community Newspaper has spent nearly 100 hours interviewing sources for this investigative series during the past several weeks.

Family and close friends of Karavalos are adamant saying that he is "100 percent innocent" and that the details surrounding the case "did not take place, period."

Karavolos and two other alleged accomplices Francisco Xavier Barraza, 33, Alfonso Eric Acuna, 32, are classified by LA County Sheriff's Department members as being part of the "Rivera 13 Gang."

Assistant District Attorney Brock Harvey Lunsford, assigned to prosecute felony cases, and the Pico Rivera Sheriff's Department, are prosecuting Karavolos, and are well aware that the alleged victim Jones has a rap sheet that consists of over 100 arrests.

Armenta arrested in 1994 for stalking Karavalos

In 1993 Karavolos met and developed an intimate relationship with Pico Rivera resident Robin Cordova. The two had a vast age difference between them; Karavolos was 18 and Cordova had just turned 40.

Prior to her relationship with Karavolos, Cordova was married to the current Pico Rivera City Councilman David Armenta. The relationship between the two soured and Armenta and Cordova split up in a contentious and even volatile manner.

When Armenta found out about the relationship, he started stalking Karavolos.

But the situation soon escalated into something much worse.

Documents obtained from the LA County Sheriff's Department confirm that Armenta was arrested and served jail time for stalking, threatening, and physically assaulting Karavolos at their Pico Rivera residence. He also violated a previous court order that had been in place due to the violent nature of the situation. against Mr. Karavolos to be upheld, despite the knowledge of Andrew Jones' redundant criminal activity.

"The criminal activity of Jones shows he has absolutely no credibility. They are allowing this whole matter to destroy and harm an innocent life," a longtime friend of Karavolos said, who also did not want to be publicly named due to "safety concerns."

Jones lived with Karavalos

HMG-CN has also learned that alleged victim Jones, and another alleged victim Luz Guadalupe Valenzuela, had several of their personal belongings at Karavolos' residence including clothes, personal hygiene products, wedding certificates, and even personal letters to other family members.

Sources have also said that investigating officers at Pico Rivera Sheriff's Department have known about the personal belongings of Jones and Valenzuela but according to a source, "have ignored the evidence since day one."

According to a private source, "the evidence shows and proves that Jones and Valenzuela were living at Karavalos' home, and that Jones is not a kidnap victim in any way shape or form."

Documents obtained from the LA County Sheriff's by HMG-CN show that Karavalos has no violent criminal history in his 38 years of life; he was arrested on minor drug charges back in 1997.

Jones, on the other hand is a different story.

Andrew Jones' long arrest record

On May 18th, 2012, a review of a Montebello Police report states that Jones is described as having been caught in the act of committing burglary. Witnesses said they initially thought Jones was washing a vehicle, and quickly discovered that Jones had actually broken into the car and was taking valuable contents. According to the report, a witness screamed out to him in an attempt to get him to stop. Jones took off running with the stolen items. A foot pursuit began and one of the other witnesses phoned 911.

In a report filed by Cpl. J. Martinez, of the Montebello Police Department, after being pursued for multiple blocks Jones was eventually captured and arrested. It is believed that Jones threw the contents of what he had stolen into some nearby bushes, shortly before being caught in the parking lot of Garduno's Italian Restaurant.

Documents show that Jones was arrested for burglary, possession of a loaded firearm, possession of burglary tools, wearing gloves during the commission of a crime, and for being "selective" in what he had stolen. then states that "the people making him do these things" had been drugging him with Methamphetamines and that they kidnapped him on Mother's Day. He also admits that he had personally used "meth" by himself for a few days prior to the arrest, and may have been awake for more than 72 hours or longer without sleep.

In a supplementary Montebello Police Department Report dated May 19, 2012, Officers Cpl. Rodriguez and N. Jarvis conducted another interview in Room # 282 where Jones makes additional statements claiming that his reason for his committing the crime was due to him being falsely imprisoned and tortured by several individuals on May 13, 2012 at Karavolos' residence; even pulling up his own shirt to display some very large burn marks on his torso to gain the belief from the investigating officers. That is when the case was transferred to Pico Rivera and Karavalos nightmare began.

Shortly after the crime and his release, Jones was arrested and convicted in Arizona in November of 2012 on various felony charges and is now behind bars for the next 7 to 25 years, according to the Arizona prosecutor Greg Stolz.

HMG-CN has learned that Karavolos hired criminal defense attorney Peter Benjamin Schlueter of Schlueter & Schlueter Law Firm.

"Armenta has hated Karavalos for almost ten years, and he finally found a way, using his influence at Pico Rivera city hall, to get back at him," a family member said. "The \$4 million bail is a testimony to the level of cover-up and corruption."

The Los Angeles County District Attorney's Communications Department was invited to comment on the case. They have not responded as of Monday, March 17th.

The two cross-town rival teams squared off against each other this past weekend in games at both Angel Stadium in Anaheim and Dodger Stadium in Downtown Los Angeles.

HBPD officials confirmed to Hews Media Group-Community Newspaper that he incident occurred at 1:45am and took place at the intersection of Main and Walnut Street.

It appears that the incident began when a woman wearing an Angel's jersey instigated a quarrel between two other women who were talking about the Dodgers.

The altercation escalated when the three Marines intervened to come to the aid of the Angels fans and in the process were allegedly attacked and stabbed by friends of the Dodgers fans.

Officials said that when officers tried to break up the fight, one of the Marines was stabbed in the face with a broken beer bottle while the two other Marines were also discovered to have been stabbed.

Police Lt. Mitch O'Brien of Huntington Beach PD stated, "The six people arrested were believed to be all part of the same group".

Police said, "Two of them were hospitalized in stable condition, while the third was treated and released for his injuries."

Documents obtained by HMG-CN by the Huntington Beach PD indicate that Alvarez and Robledo were released from jail on Monday after they posted \$25,000 bond.

According to a report published in the L.A. Times, and written by John D. Wagner on November 17, 1994, Armenta was later convicted by a Los Angeles Superior Court and placed on probation for over a year.

Sources, who did not want to be publicly identified for safety concerns, say that Armenta has held a grudge against Cordova and Karavolos since the arrest, and that Armenta used his authority as a current city councilmember to influence the case involving Karavolos.

Observers familiar with the case say that the Sheriff's Department and prosecuting Deputy District Attorney Brock Lundsford are still turning a "blind eye" allowing the accusations that were made He was booked on May 18th, 2012 at around 10:30 p.m.

According to the report, Officer J. Castillo conducted the initial interview with Jones and reported that Jones spontaneously stated, "some guys made me do it."

According to the Montebello Police records obtained by HMG-CN, Karavolos was never mentioned in the interview, nor was he considered a party to any of Jones' allegations.

The records also showed that Jones possessed a key to Karavolos' home at the time of his arrest.

VERSTEEG'S COMPLETE GAME SHUTOUT SETS TONE FOR GAHR'S DOUBLEHEADER SWEEP

LONG BEACH-Gahr's baseball team may not be as experienced as it was last season but don't tell that to Long Beach Poly. Junior lefty Paul Versteeg owned the first game of a doubleheader at Blair Field last Saturday afternoon while timely hitting and five Poly errors allowed the Gladiators to complete the sweep in the nightcap.

Versteeg scattered eight hits in picking up the team's first complete game of the season and Gahr scored four times in the first three innings en route to a 5-0 win. The Gladiators then rallied from two runs down to edge the Jackrabbits 7-6 in the nightcap.

"I think our kids are buying in," said Gahr head coach Gerardo Perez. "If a call doesn't go your way, whether it's a strike call or a safe call or somebody makes an error, the general feeling is let's pick them up and let's do it anyways regardless of the call, regardless of the situation."

Versteeg was in a zone in the opener and getting help from his defense at the same time. With runners at the corners and two outs in the bottom of the first, he induced Tai Tiedemann into a groundout. Two innings later with runners on second and third, he got Josh Rios to fly out to senior right fielder Saul Flores. And with the bases loaded with two outs in the fifth, he got out of the jam when Matt Palacios popped up to senior first baseman Nick Guerra.

In all, Versteeg struck out five, walked none and threw 85 pitches in one of the best pitching performances by any Gahr hurler. But according to Perez, it wasn't the best.

"I would have to say [senior] George Castillo at Mater Dei," Perez said. "When you no-hit them and strike out 11 or 12... that was a pretty dominant performance. Paul, for four innings at Orange Lutheran, was just as good as he was today. They're very formidable opponents, so I thought they did well."

"I felt like today was an important day," Versteeg said. "I had my defense behind me. There were a lot of ground balls and I relied on my defense a lot."

Senior designated hitter Adrian Poot's first of two base hits drove in sophomore third baseman Jesus Salazar in the top of the first for the only run Gahr would need. The Gladiators would add two more in the second, one in the third and the last run in the sixth. Senior shortstop Jaime Estrada went two for three as Gahr was limited to half a dozen hits. But the Jackrabbits also committed five errors.

In the nightcap, the Gladiators built a 4-1 lead after two innings, thanks to Estrada's two-run triple in the second. But Poly scored three runs in the third and took a 6-4 lead in the fourth.

But with two outs in the sixth, Gahr began to make its comeback. Junior second baseman Joe Dressel singled, moved to second on an error and scored when junior left fielder Leotis Johnson was safe on another error, which eventually allowed him to go to third. Senior right fielder Eric Cummings then tied the game on an infield hit with Johnson coming home.

In the next inning, Gahr took a page out of its playbook from a 2-1, eight inning win against Mater Dei earlier this season. With Estrada on third and Poot on first with one out, junior first baseman Jorge Rivas laid down a bunt that went up the first base side and threw the legs of Poly's first baseman as Estrada came home.

"When [Jorge] says, 'let's a pull a Mater Dei', which is a real similar ending to the Mater Dei game," Perez said. "I said, 'let's do it' and we attacked it and that's part of the game plan we had going in."

Estrada picked up two more hits while Dressel also had two hits. Guerra pitched the final two innings, striking out two and allowing only one base runner for his first win of the season.

"From an offensive standpoint, we're executing," Perez said. "We've done a very good job of team offensive baseball. I don't think we scare anybody. I don't think we have any mustaches and I don't think we're real physical. We're young but we're very baseball savvy and we're a real good team at this point. But we have to continue to grow."

Gahr would see its five-game winning streak snapped this past Wednesday after falling to Long Beach Wilson 4-2 in a Redondo Tournament game. But at 9-2, the team is just going through the everyday motions and not trying to compare itself to last season's team, or any other team in the past.

"I just feel like this year we're a closer team; a lot of bonding this year," Versteeg said. "Nobody is a powerhouse kind of guy. But everyone has the tools and we can put it together and we work well."

"I really put a lot of emphasis on having a highly competitive, highly efficient, high level of practice with perfection," Perez said. "I have to give credit to this coaching staff. Coach [Pepe] Miranda has done a great job. Coach [Ryan] Juarez has done a great job. They've really helped formed and developed young guys at an earlier pace with their patience and with their expectations."

Gahr will host La Serna on Saturday and begin San Gabriel Valley League action on Tuesday with a home game against Warren.

SAN GABRIEL VALLEY LEAGUE SOFTBALL Gahr freshmen provide late inning dramatics in rare league-opening victory

Like many of its opponents this season, Gahr showed Downey that if you try to bat around, or hit any batter in its potent offensive lineup, the next batter will make you pay. So, when Anissa Hamilton plunked freshman third baseman Malia Quarles on the first pitch to lead off the bottom of the seventh, Gahr was right where it wanted to be.

Two pitches later, freshman first baseman Alyssa Kumiyama sent the hosts home happy with a blast over the right center fence as Gahr opened up San Gabriel Valley League play with a 7-5 win. Gahr snapped an 11-game losing streak to the Vikings and in the process, won a league opener for the first time since 2009.

After seeing the Vikings take the lead with three runs in the top of the fifth, the Gladiators tied the game in the bottom half of the frame when Kumiyama scored on a wild pitch with two outs. Then freshman pitcher Naomi Dickerson replaced junior Deidra Genera in the top of the sixth and retired six of the seven batters she faced. That was more than enough to give the offense a chance with Malia Quarles, Kumiyama, junior second baseman Celeste Gonzalez and junior catcher Brianna Besenty all due to come up in the bottom of the seventh. Those are currently the top four hitters with none hitting below .370 and combining for 15 of the team's 19 home runs.

"I definitely liked our chances at that point," said Gahr head coach Shawn Quarles. "We still had to let it all happen and it all had to unfold."

"Just get a base hit and try to get my team going and hopefully help us get that win," Kumiyama said of her thoughts as she was walking up to bat, "I wasn't really thinking anything up there."

Downey gained an early 1-0 lead in the first inning on an run scoring hit from Daphne Gaspar but Gahr (8-8 overall, 1-0) quickly tied the game when Malia Quarles smacked a two-out home run to dead center. It was her third home run in her last five trips to the plate as she increased her season total to eight.

Downey would regain the lead the next inning but the Gladiators went up 4-2 in the bottom of the third, beginning with a sacrifice fly from Kumiyama. With two outs, Hamilton hit Gonzalez, surrendered a base hit to Besenty, which scored Malia Quarles, and yielded another base hit, this one to sophomore center fielder Alyssa Cuffia.

After a scoreless fourth inning, Downey took a 5-4 lead in the fifth as all three runs were scored with two outs.

"It was definitely intense but I knew our girls had the capability of coming out and just doing what they do," Kumiyama said of the game. "It's just a great team; I love my girls."

"It was definitely a good win," Shawn

Quarles said. "Downey was tough. I knew they were going to be tough, I knew they were going to hit. So, it was kind of like a slugfest. But it was definitely a big win that we wanted to get under our belts."

Kumiyama and Malia Quarles combined for five of the eight hits Gahr would get. Both are batting well over .400 this season with the latter leading the team at a .479 clip. Of her 23 base hits, 14 have gone for extra bases.

"They're just great hitters," Shawn Quarles said. "We're just fortunate to have them. It's totally abnormal to have that [production] out of three and four [in the lineup]. And to have them as freshmen right now is just amazing. I think they are the two best hitting freshmen in the country."

"I was definitely expecting to maybe struggle but knowing who I am, I know I can battle back through any struggle," Kumiyama said. "Just staying humble is what compensates for that."

Gahr visited Lynwood on Apr. 3 and will host Warren on Tuesday in a crucial match-up of the top two teams in league. Gahr has lost 10 straight games to the Bears but will have the services of junior Destiny Vasquez, who transferred from Norwalk but had to sit out the first 30 days of the regular season. Vasquez could get the start in the circle, but Shawn Quarles still isn't 100 percent decided on that as of now. "Destiny is a great all-around player and we're fortunate to have her," he said. "We're glad to get this win in."

If Gahr knocks off Warren, it will be its first win against a team with a winning record this season, leaving many to wonder if Gahr's 8-8 record is a bit misleading despite the team hitting .346 with 19 home runs, the most since belting 20 home runs in 2005.

"It is [misleading], because at any given day someone can just show up and take the win," Kumiyama said. "But it's all about staying humble and playing Gahr softball."

legislations to this effect have emerged during the recent legislative session in the Capitol that included HR 29 by Assembly Member Jimmy Gomez, Assembly Bills 1574, 1575 and 1578 by Assembly Member Richard Pan.

With HR 29, legislators are asked to vote on bills that oppose "outsourcing of public services and assets." It also compels the Assembly to introduce outsourcing legislations. "Not only this resolution is harmful in its content, it also undermines the democratic process and representative government because legislation looses the opportunity to make an informed decision about the specific inputs of pending legislation," stressed Croft.

"Recently, there seem to be an increasing push by groups such as AFSCME (American Federation of Southern California Municipal Employees) for contract legislation," Chambers added. He continued, last year, they sponsored AB 1333 by AM Roger Hernandez, and Senate Bill 556 by State Senator Ellen Corbett sponsored by CLF.

Senator Holly Mitchell spoke to the crowd "Childcare is a critical pillar when talking about women succeeding." ORDINANCE NO. 985

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CERRITOS AMENDING CHAPTER 9.49 OF THE CITY OF CERRITOS MUNICIPAL CODE PROHIBITING THE SMOKING OF TOBACCO PRODUCTS AND USE OF ELECTRONIC CIGARETTES AT ALL CITY OWNED AND/OR OPERATED FACILITIES.

WHEREAS, Chapter 9.49 of the Cerritos Municipal Code prohibits smoking of tobacco products in the City of Cerritos, and specifically, at City owned or operated facilities; and

WHEREAS, to protect and promote the public health, safety, and welfare, the City Council of the City of Cerritos now desires to modify Chapter 9.49 to re-define the types of smoking that are prohibited, including the prohibition of the holding, possession and control, operation, and/or use of e-cigarettes, and the locations where such activity is prohibited.

THE CITY COUNCIL OF THE CITY OF CERRITOS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Chapter 9.49 of the Cerritos Municipal Code is hereby amended and shall now read as follows:

Chapter 9.49 Smoking Regulations

9.49.010 Definitions.

9.49.020 Locations Where Smoking Is Prohibited. 9.49.030 Notice by Signage.

Section 9.49.010 Definitions.

"Smoke" or "Smoking" means and includes the holding, possession and control, operation, and/or use of: (1) any burning or lighted tobacco product, lighted tobacco paraphernalia, or any other lighted weed or plant including, but not limited to, a lighted pipe, lighted hookah pipe, lighted cigar, or lighted cigarette of any kind; or

(2) any burning, lighted, operating or functioning electronic and/or battery operated device that can deliver an inhaled dose of nicotine or other substances, including, but not limited to, any device manufactured, marketed, or sold as an electronic cigarette, cigar, cigarillo, or pipe.

Section 9.49.020 Locations Where Smoking Is Prohibited.

Smoking is prohibited in the following locations:
(1) On the exterior and/or interior grounds of the Cerritos Civic Center.
(2) Within the boundaries of any park as defined in Chapter 9.48.
(3) On the exterior and/or interior grounds of any City-owned or operated recreation
facility.
(4) At Cerritos Iron-Wood Nine Golf Course, including the patio, putting green, and
driving range, and excluding the golf course itself.

(5) In any area of public assembly within any building which is City owned or operated.

Section 9.49.030 Notice by Signage.

Locations where Smoking is prohibited shall be identified by one or more conspicuously posted signs.

Section 2. Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases of this Ordinance, or its application to any other person or circumstance. The City Council hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance, irrespective of the fact that any one or more other sections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable.

Section 3. Effective Date. This Ordinance shall take effect thirty (30) days after its adoption in accordance with California Government Code section 36937.

Section 4. Certification. The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published and/or posted in accordance with applicable law.
